Requirements and Qualifications

Candidates should have obtained a Doctorate of Pharmacy degree from an accredited college of pharmacy in the U.S. Those applying should be eligible for licensure in the Commonwealth of Kentucky by September 1st.

Candidate should submit the following for consideration:

- + Curriculum vitae
- + Three letters of recommendation
- + Official university transcripts
- + Letter of intent explaining why you are pursuing a managed care pharmacy residency and what you hope to gain from the program.

All completed materials should be submitted to PhORCAS by the first Friday in January for candidates to be considered for the program. Candidates may receive invitation for an on-site interview.
